**ORDER:**

**WHEREAS**, the undersigned in the capacity of Chief Purchase Officer, Special Purchase Committee (Education) Toba Tek Singh in due consideration of the facts that M/S ZA Traders, Madina Town, Chak Shahana Road, Khanewal failed to supply the furniture items (3- Seated Desk Bench & Student Chair) to 82 schools out of 363 schools within the stipulated period of time even after a laps of 1 and half year. The detail of the 82 school to which the supply of furniture was not made.

**AND WHEREAS**, M/S ZA Traders, Madina Town, Chak Shahana Road, Khanewal was declared successful bidder, by the Special Purchase Committee, Toba Tek Singh being the lowest in rates for supply of 3-seated Desk Bench and Students Chair in participating the tender notice published through DGPR Lahore on 04-12-2014 and 363 school issued supply / work order to the said firm time to time and were required to supply within stipulated time but the firm failed to supply the furniture within stipulated period of time.

**AND WHEREAS**, a show cause notice was served to the above said firm vide this office No. 5498/P&D dated 04-10-2016 to show cause, in writing, within 07 days of the receipt of the notice but the firm failed to do so. A reminder was issued vide this office No. 6406/P&D dated 14-11-2016 and directed to appear before the undersigned within the 03 days alongwith defence reply.

**AND WHEREAS**, Syed Muzaffar Ali from M/S ZA Traders, Madina Town, Chak Shahana Road, Khanewal appeared before the undersigned on 16-11-2016 and stated that he has stopped the supply of furniture due to non-cooperation of the schools and enquiry held by the CMIT. He also requested to extend the time for supply of furniture upto 31-12-2016.

**AND WHEREAS**, a reference No. 6467/P&D dated 16-11-2016 was submitted to the District Coordination Officer for further necessary action against the defaulter firm M/S ZA Traders, Madina Town, Chak Shahana Road, Khanewal due to failed in supply of furniture within stipulated period even after a lapse of more than one & half year.
