

ORDER

WHEREAS, M/s Good Luck Stationers & Printers, 53 - Chatterjee Road, Urdu Bazar, Lahore was issued Supply Order for supply of Electric Generator on April 08, 2016. The Electric Generator supplied by M/s Good Luck Stationers & Printers was rejected by the Technical Committee on the basis of following facts:

- The Electric Generator was an old one whereas as per tendered item, it should be a new one.
- The supplied Electric Generator was not in compliance with the technical bid submitted by the M/s Good Luck Stationers & Printers.
- The supplied Electric Generator was not meeting this office requirements as no documents (i.e. datasheet, shipping document, load certificates, Manufacturer warranty card etc.) were provided by M/s Good Luck Stationers & Printers.
- The supplier M/s Good Luck Stationers & Printers fails to furnish the Performance Security within fourteen (14) days of the receipt of supply order.

Therefore, the Technical Committee recommended to pledge the security deposited by the Bidder under Clause 15.2 of Tender Document and blacklist the supplier of Electric Generator i.e. M/s Good Luck Stationers & Printers under PPRA Rule 21 as he failed to perform his obligations under the contract and acted in the manner detrimental to the public interest or good practices.

WHEREAS, a Show Cause Notice was issued to supplier M/s Good Luck Stationers & Printers on June 16, 2016 under PPRA Rule 21 regarding blacklisting of the firm and pledging of the security deposit.

WHEREAS, M/s Good Luck Stationers & Printers submitted the reply to the Showcause Notice on June 22, 2016 which comprises of some irrelevant denunciation, personal grudges for rejecting the substandard Electric Generator and to blackmail the members of the Technical Committee. The reply also indicate the malafide intentions to influence the members of Technical Committee to accept the substandard/used Electric Generator. The dissatisfaction of the procuring agency on the reply of Showcause Notice submitted by M/s Good Luck Stationers & Printers was communicated to him on July 19, 2016.

WHEREAS, the case was referred to Secretary Home, Government of Punjab for further direction who directed to initiate the action against the contractor being the Procuring agency as provided in the PPRA Rules.

NOW THEREFORE, Director Civil Defe Punjab being competent authority hereby forfeit the bid security of the firm and order for the blacklisting of M/s Good Luck Stationers & Printers, 53 - Chatterjee Road, Urdu Bazar, Lahore for a period of one year.
