WHEREAS, the undersigned in the capacity of Procuring Agency, School Education Department, District Government, Layyah in due consideration of the facts that M/S Computer Communication Technology, Suit No.27, Ground Floor, Abrar Business Centre, 25-Main Wahdat Road Lahore, failed to deposit Government Liabilities i.e GST Rs. 633441/- and Income Tax Rs. 549144/- after the laps of 18 Months against the supply orders for the provision of I.T Lab Equipment to H/S, M/S (Boys & Girls) of District Layyah during FY 2014-15 of Total Amount of Rs. 42.70 (M)

2. AND WHEREAS, M/S Computer Communication Technology, Lahore was declared successful bidder by the District Purchase Committee Layyah being the lowest offered rates for supply of I.T Lab Equipment to H/S, M/S (Boys & Girls) of District Layyah during FY 2014-15 in participating the tender process, as per SRO No.897 (I)/2013 dated 04.12.2013 issued by the Federal Board of Revue, Rs.607630/- was deducted by this office as GST and the remaining amount Rs.633441/- was Paid to the Firm which was mandatory to deposit the same in to government treasury under the rules. But the firm could not do so after laps of 18 Months. Moreover, an amount of Rs. 549144/- (Government Revenue) out of total Income Tax Rs. 1921835/- is still outstanding with M/S Computer Communication Technology, Lahore.

3. AND WHEREAS, a series of letters (14 No's w.e.f 26.02.16 to 02.09.16) was issued by this office as well as via telephonic conversation a no of times to deposit the outstanding liability under the provision of rules but all in vain.

4. AND WHEREAS, in this context a show cause notice was served to the M/S Computer Communication Technology, Lahore vide this office letter No. 7986/B&A dated 16.11.2016 under rule 21(6) of PPRA and subsequent schedule added after rule 70 vide Notification No. SO (Cabent-I)2-9/2015 dated 06.01.2016 on the charges of Non-Deposit of Revenue and directed to submit his written reply within seven days but the concerned firm did not response positively. A personal hearing notice was issued vide no. 8207/B&A Dated 26.11.2016 under rules 21(6) of PPRA and directed to appear before the Purchase Committee on 01.12.2016 at 2.30.pm for their defense.

5. AND WHEREAS, in response of Personal Hearing Notice, Mr. Azam Anwar, representative of firm attended this office on 01.12.2016 but neither he provide any record/ deposit challans of remaining Income Tax and GST and nor provide any written statement in the defense of his firm.

NOW WHEREAS, I, Muhammad Mansha Meo, Executive District Officer (Education), Layyah in the capacity of Procuring Agency, School Education Department, District Government, Layyah with the approval of District Coordination Officer, Layyah declare as blacklisted firm "M/S Computer Communication Technology, Suit No.27, Ground Floor, Abrar Business Centre, 25-Main Wahdat Road Lahore" and debar in tendering process from School Education Department for further 18 Months with immediate effect.
