

## ORDER.

1. **WHEREAS**, an agreement was made between District Education Officer (Special Education) Rawalpindi and M/S Saqib & Brother, H-CB # 1330 (old 836), St. # 19, Millatabad, Dhoke Chudrian, Rawalpindi, for the supply of uniform items (sweater, shawl and vest) to special students of Special Education Institutions of District Rawalpindi, during the year 2015-16.

2. **AND WHEREAS**, M/S Saqib & Brothers, Rawalpindi has failed to replace the substandard uniform items, which have supplied by his firm, to the Special Students of following Special Education Institutions of District Rawalpindi during the year 2015-16.

- i. Govt. Al-Ghazali Special Education Centre for PHC, Rawalpindi.
- ii. Govt. Institute for the Slow Learners, Rawalpindi.
- iii. Govt. Special Education Centre Kahuta, District Rawalpindi.

3. **AND WHEREAS**, the District Education Officer (Special Education) Rawalpindi wrote a letter to M/S Saqib & Brothers Rawalpindi vide No. DEO(Spl.Edu.)Rwp/16/549, dated: 19-03-2016, in which M/S Saqib & Brothers Rawalpindi was directed to replace the sub-standard items, supplied by his firm to the Special Students of above Special Education Institutions of District Rawalpindi.

4. **AND WHEREAS**, the Executive District Officer (CD) Rawalpindi wrote a letter to M/S Saqib & Brothers Rawalpindi vide No. EDO(CD)Rwp/Misc-358, dated: 22-04-2016, in which M/S Saqib & Brothers Rawalpindi was directed to replace the sub-standard items, supplied by his firm to the Special Students of above Special Education Institutions of District Rawalpindi, but in vain.

5. **AND WHEREAS**, a show cause cum personal hearing notice was served to M/S Saqib & Brothers, Rawalpindi by the District Education Officer (Special Education) Rawalpindi vide No. DEO(Spl. Edu)/Rwp/16/933, dated: 04-05-2016. In this notice, M/S Saqib & Brothers Rawalpindi was directed to show the reasons that why he has not complied with the above mentioned job. He was directed to submit the reply within 07-days. He was also offered an opportunity of personal hearing, personally or through any authorized agent before the DEO (Special Education) Rawalpindi on 12-05-2016 at 11:00 a.m, but he failed to do so.
