BLACKLISTING OF M/S PROGRESSIVE ASSOCIATE, RAHIM YAR KHAN UNDER RULE 21 OF PPRA RULES 2014.

BRIEF FACTS.

Furniture for (25) Govt. High and higher secondary schools and Conference room, Office of E.D.O (Education), Rajanpur was purchased in 2015-2016 through competitive bidding process. Tender was floated on 28.01.2016. M/s Progressive Associate, Rahim Yar Khan was qualified as the lowest bidder. The firm failed to supply the allotted material.

2. In this regard, the undersigned conveyed the concerned firm to supply allotted material vide this office No. 1527, dated 15.07.2016 reminders No. 1687, dated 13.08.2016, a meeting was held on 11.11.2016 and brought to the notice of chairman procurement committee regarding above narrated circumstances.

3. As per approval of purchase Committee, the supply order issued vide this office No. 1390, dated 17.06.2016 was cancelled in favour of M/s Progressive Associate. Rahim Yar Khan vide this office letter No. 4897/admn dated 23.11.2016.

ORDER:


1. **WHEREAS**, despite repeated requests for supply of furniture as per agreed terms and conditions, the firm failed to perform its obligation in responsible manner.

2. **WHEREAS**, the undersigned served a show cause cum personal hearing Notice vide No. 5035, dated 10.12.2016 under clause 1 of

schedule {see sub rule (6) of rule 21} of PPRA Rules 2014 and directed to appear before the undersigned on 19.12.2016 But the Manger of above said firm marked attendance on said day but neither appeared before the undersigned nor submitted any written defense.

3. **WHEREAS**, a personal hearing Notice was served to Contractor of Progressive Associate, Rahim Yar Khan vide this Office No. 5153/Admn dated 22.12.2016 to defend his position. But he repeated previous practice and marked attendance and did not appear before the undersigned nor submitted any written reply/ evidence. It shows that Contractor of Progressive Associate. Rahim Yar Khan has nothing to defend his position.

Forgoing of the above, I Abdul Ghaffar Khan Langah, Executive District Officer (Education) Rajanpur empowered under sub rule 1 of Rule 21 of PPRA Rules 2014 hereby **debar / blacklist Progressive Associate, Rahim Yar Khan from Participating in any public procurement process for 10 year.**
