

ORDER

WHEREAS, the undersigned in the capacity of Procuring Agency, School Education Department, District Chakwal in due consideration of the fact that M/S Chaudhary General Order Suppliers, Chakwal, AL-Rehman/NBP Building, First, Floor District Complex, Chakwal was enlisted in School Education Department (Office of the Executive District Officer Education Chakwal now Chief Executive Officer (DEA) for supplying computer systems to High/Higher Secondary Schools (M/F) in District Chakwal during the financial year 2015-16 against the supply orders.

2. **WHEREAS**, The undersigned issued two formal supply orders to M/S Chaudhary General Suppliers, Chakwal for supplying of 160 computer systems to High/Higher Secondary Schools (M/F) in District Chakwal vide No. 1515/Dev dated 07.04.2016 and No. 2111/Dev dated 23.05.2016 with time limit 30 days. I framed the following charges against the firm:

1. One hundred and sixty (160) Computer Systems has not been supplied to High/Higher Secondary Schools (M/F) in District Chakwal within the time as per supply order/contract.

3. **WHEREAS**, three reminder notices, were served upon the firm vide No. 1972/Dev. dated 11/05/2016, No. 3090/Dev. dated 04/08/2016 and No. 2828/Dev dated 20/07/2016 by the Executive District Officer (Education) Chakwal for completion of above said supply. .

4. **WHEREAS**, a personal hearing notice was also issued to the firm by the undersigned vide no.5803/Dev Dated 18.10.2016 and directed to appear before the District Coordination Officer Chakwal chairman District Purchase Committee on 19.10.2016 for their defense. Mr. Muhammad Shabbir, representative of the firm attended the meeting and no positive reply was given by the representative of the firm. The firm did not comply with and stated that Processor Core i-5 3.4GHZ 4th Generation is not available in the market. However same generation with more capability processor is available at current time. The firm provided. two alternative solutions for supplying the computer systems of different/irrelevant specifications, in contradiction to tendered specification. The technical committee rejected this offer.

6. **NOW THEREFORE**, I, Dr. Ghulam Murtaza Anjum, Chief Executive Officer, District Education Authority, Chakwal in the capacity of procuring Agency, School Education Department, District Chakwal with the approval of District Coordination Officer, Chakwal declare as **blacklisted** firm that M/S Chaudhary General Order Suppliers, Chakwal, AL-Rehman/NBP Building, First Floor, District Complex, Chakwal and debar in tendering process during the financial year 2016-17.
