

ORDER

WHEREAS, the undersigned in the capacity of Procuring Agency, School Education Department, District Chakwal in due consideration of the facts that M/S MAK & MAK, Apartment No. 401, 4th Floor, Al-Madina Heights, plaza No.71 Civic Centre, Phase-IV, Bahria Town, Rawalpindi, failed to supply 20 Printers to High/Higher Secondary Schools (M/F) in District Chakwal during the financial year 2015-16 against the supply order.

2. **WHEREAS**, the undersigned issued three formal supply orders to M/S MAK & MAK, Rawalpindi for supplying of 20 Printer to High/Higher Secondary Schools (M/F) in District Chakwal vide No. 421/Dev Dated 03.02..2016 and No. 1570/Dev Dated 08.04.2016 and 2113/Dev Dated 23.05.2016 with time limit 30 days. I framed the following charges against the firm:

1. 20 (Twenty) Printers has not been supplied to High/Higher Secondary Schools (M/F) in District Chakwal within the time as per supply order/contract.

3. **WHEREAS**, vide this Office letter No. 1076/Dev. dated 15.03.2016 you were requested for depositing CDR at the rate of 5% of the amount against which you won the tender but no response was given by your firm. Moreover four reminder notices served upon the firm vide No. 893/Dev. Dated 03.03.2016, No. 1513/Dev. Dated 06.04.2016, No. 1803/Dev. Dated 28.04.2016 and No. 2412/Dev. Dated 10.06.2016, by the undersigned for completion of above said supply.

4. **WHEREAS**, a personal hearing notice was issued to the firm vide No.5804/Dev. Dated 18.10.2016 as well through telephonic message under rules 21(6)of PPRA and directed to appear before the District Coordination Officer Chakwal chairman District Purchase Committee on 19.10.2016 for their defense. The firm did not appear before the competent authority on the said date and thus failed to submit any defense in charges leveled against the firm.

5. **NOW THEREFORE**, I, Dr. Ghulam Murtaza Anjum, Chief Executive Officer, District Education Authority, Chakwal in the capacity of procuring Agency, School Education Department, District Chakwal with the approval of District Coordination Officer, Chakwal declare as **blacklisted** firm that M/S MAK & MAK, Apartment No. 401, 4th Floor, Al-Madina Heights, plaza No.71 Civic Centre, Phase-IV, Bahria Town, Rawalpindi and debar in tendering process during the financial year 2016-17.
