Subject: BLACK LISTING OF M/S WASEEM TRADING CORPORATION, 821, JALANDER BUILDING KASHIF HOUSE AHMED NAGER JHANG ROAD, JHANG SADAR, AT FIC, FAISALABAD.

Work order regarding "Provision of Iron Grill to be Installed / Fixed around the Emergency Front Lawn at Faisalabad Institute of Cardiology, Faisalabad" amounting to Rs.1,710,528/- with time limit of three months was given to M/s Waseem Trading Corporation, 821, Jalander building kashif House Ahmed Nager Jhang road, Jhang sadar vide letter No. 29886/FIC/FSD dated 19.08.2016.

M/s Waseem Trading Corporation started work and work was slow therefore your firm was advised to execute/complete work within stipulated period vide letter No. 44665/FIC/FSD dated 20.12.2016, the your firm not responded.

**1<sup>st</sup> reminder** vide letter No. 45896/FIC/FSD dated 31.12.2016 was sent to the address of your firm to complete the work within shortest time but your firm did not responded.

**2<sup>nd</sup> reminder** failure to work done vide letter No. 1426/FIC/FSD dated 11.01.2017, once again you were directed to complete the work within 15 days from issuance of letter, in which you were warned to complete the work otherwise a strict legal action will be initiated against your firm under the terms and conditions of the contract, your **CDR will be forfeited**. Furthermore the **black listing** of your firm will be recommended to Health department Lahore & PPRA Punjab.

**3<sup>rd</sup> and final reminder** vide letter No. 4393/FIC/FSD dated 15.02.2017 was sent to the address of your firm in which you was asked to complete the work without further delay within 07 days from issuance of this letter otherwise a strict legal action will be initiated against you under the terms and conditions of the contract, your CDR will be forfeited. Further the black listing of your firm will be recommended to Health department Lahore & PPRA Punjab, but your firm did not responded and not started work.

A letter for **personal hearing** vide letter no. 5760/FIC/FSD dated 02.03.2017 was sent to your address through register dak, but nobody appeared before the committee.

your firm filed a case in Lahore High Court, Lahore for exemption of PST on services 16%, whose decision was received through letter No. 14694 dated 13.03.2017 in which Honorable High Court advised ("it is apprised that PC-1, based on which the service in question are be provided, shall be examine to see whether petitioner falls within exemption notification dated 05.10.2016 or not,,)

Our legal advisor studied the Court orders and gave his expert opinion that the said case does not fall in any kind of exemption. This was informed vide letter No. 7333/FIC/FSD dated 28.03.2017 and also telephonically to you and you was asked to start the construction work within 24 hours, because a lot time has been wasted and due to this our institution is facing a lot of problems, you refused to start the work during telephonic conversation and informed to approach the Honorable High Court, Lahore again. You also not started the work within 24 hours. Keeping in view the above circumstance.

The competent authority has decided to black list your firm for (02) two years in this institute. According to PPRA Rules 2014, rule No. (21) clause (3) "if a procuring agency is satisfied that a contractor has acted in a manner detrimental to the public interest or good practices or has consistently failed to perform his obligation under the contract or his performance has not been up to mark or he is found indulging in corrupt or fraudulent practice, the procuring agency may, after affording him an opportunity of hearing and through a notification, debar him from participating in any public procurement process of the procuring agency for such period as the procuring agency may determine in the light of the circumstances of the case".
