This is with reference to the bid for "Build, Operate and Transfer (DBOT) of Bio Gas Plant of One (01) Ton/ Day Waste Capacity with Output Gas Volume of 200M at Ichogill", Lahore dated 26th May, 2014.

Besides giving a Show Cause Notice, reference Letter No: LWMC/MD/872 dated: March 16, 2017 and multiple reminders to you, reference Letter No: 1302 dated April 10, 2017 and reference Letter No: LWMC/MD/1393 dated: April 18th 2017, you failed to prove yourself in a particular manner.

Saadat Ali & Company for personnel hearing but instead of appearing personally before the LWMC management, M/s Maxrite Global Technologies (Pvt) Ltd JV M/s Sh. Saadat Ali & Company sent Dr. Muhammad Akmal to prove himself, where he was unable to defend his side therefore it has been decided to blacklist and bar M/s Maxrite Global Technologies and M/s Sh. Saadat Ali & Company from any future public procurement of Punjab province for a period of one (01) year. The period will start from the date of issuance of this letter.
