

Subject: **FINAL EVALUATION REPORT – REPAIR OF (08) OFFICIAL VEHICLES (04 LOTS) OF TRANSPORT POOL, SR&AD**

Tenders were invited through publication of advertisement in a newspaper i.e. "Daily Durraya" dated 11.08.2017, from interested firms for repair of Eight official vehicles (4-Lots). The last date of submission of tenders was 24.08.2017 at 2:00 P.M which were opened on the same day at 2:30 P.M.

A meeting of the committee for opening / evaluation of Technical & Financial Bids for repair of Eight official vehicles (4-Lots) was held on 24.08.2017 at 2:30 P.M in the office of Deputy Secretary (MT). The following firms participated and submitted their Technical Bids:


