3. Only GST registered companies/firms can apply.
4. 3 Years Parts and Labor warranty for all the components on site for the quoted equipment.
5. Maximum of 48 hours down time for all components including replacement of the whole unit anywhere in the province.
6. The bidders are required to participate for the whole LOT on turnkey basis.
7. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or Proposal.(Rule35(1))PPRA 2014
