The tender will not be issued without authority letter on judicial paper from the Contractor/Firm along with registered partnership deed, attested power of attorney on stamp paper. The tender/bidding documents are available and will be issued by the Head Clerk/Assistant of this office during the office hours after publication of notice in PPRA Website on payment of tender fee as admissible under the rules. Tender rates and amounts should be filled in figures as in word. Tender should be signed as per general direction given in the tender documents.

Tender will be received in the office of Director General, PHA Sargodha up to 10.00 AM on the date of receiving of tender and will be opened after 30 minutes by the Tender Committee in the presence of intending contractors or their representatives. Conditional tenders will not be accepted. Under the rule 35 of PPRA, the undersigned have the right to reject any or all the tenders prior to acceptance of a bid or proposal. Tenders not accompanied with 02% of estimated price in the shape of deposit at call of schedule Bank, will not be entertained.


