1. It is intended that funds will be applied to eligible payments under the contract for which this invitation to prequalifications are issued.
2. The Executive Engineer, PHE Division Bahawalpur intends to prequalify contractors for the aforesaid works.

Prequalification is open to contractors registered with PEC for the year 2021-22 in the relevant category & established/recognized with HOD & PHE Department for the year 2021-22 and also having relevant experience as required in the prequalification document & excellent reputation in the construction of large scale Public Health Engineering Departments Projects (PEC Codes CE-09, CE-10 and CE-11) to undertake the projects.

A complete set of prequalification documents may be purchased by any interested eligible firm/contractor on the submission of a written application in English clearly stating "Request for prequalification" mentioned in this notice to the address below and upon payment of non-refundable fee of Pak Rupees 10000/- for each scheme. Under no circumstances can client be held responsible for late delivery or loss of the documents. The documents will be available during office hours (Monday to Saturday 09:00 AM to 04:00 PM up to 24-08-2021). The documents must be duly completed in the English Language and returned to Executive Engineer PHE Division Bahawalpur by 04:00 PM on 27-08-2021. Prequalification documents received after this dead line will be rejected and returned unopened. The prequalification proposal shall be sent to the Executive Engineer PHE Division Bahawalpur in sealed envelope either by hand or by registered mail, clearly marked application to prequalify for schemes mentioned in this notice.

Applications will be examined & results shall be intimated after evaluation by the Pre-qualification Evaluation Committee constituted by the Chief Engineer, (South) Punjab PHE Department 2-Lake Road Lahore, vide Notification No.16-A/1455/P&D dated 27-07-2021, "the competent authority". Only prequalified contractors will be allowed to participate in the tendering process.
5. All documents submitted by the applicants shall be treated as confidential.
6. The Prequalification committee reserves the right to reject or accept any application and the prequalification process without assigning any reason.
7. The decision of Prequalification Committee on the acceptance or rejection of application for prequalification is final & shall not be challenged at any forum & Court of Law.
