

RATE/QUOTATION FORM FOR THE SUPPLY OF PESTICIDES UPTO 30-06-2022.


I/We do hereby declare that I/We have read the following conditions of Tender/Quotation for the supply of Pesticides:-

1. The Tender Forms will be issued on the payment of **Rs.200/-** per tender.
2. Conditional Quotations / Rates will not be accepted.
3. The quotations / rates will be opened by the Purchase Committee in presence of quotationers in the office of undersigned on the dates as mentioned in advertisement notice.
4. Only companies / authorized dealers (Registered with Sales Tax) can be offered their Quotation / Rates.
5. The questioners will have to provide samples of their products along with their literatures to the Purchase Committee before opening the tenders.
6. The supply order shall be issued after observing the formalities and approval of rates by the Purchase Committee.
7. The supplier of Pesticides will be responsible to supply the pesticides within 10 days of issue of supply order.
8. The pesticides should be supplied from fresh stock of standard quality and in sealed containers/ packing according to approved rates/ specification etc.
9. It will be responsibility of supplier to deliver the pesticides in the office of Divisional Forest Officer, Pest Control Forest Division, 108-Ravi Road Lahore on their own level. No loading / unloading charges will be paid.
10. The questioners will have to deposit C.D.R. of Rs.58000/- in favor of Divisional Forest Officer, Pest Control Forest Division Lahore along with quotation / tender as 2% security of total amount refundable after completion of tender enquiry proceedings. The successful bidder will have to deposit further 10% of value of supply order as security refundable on completion of the whole supply of pesticides during the year 2021-22.
11. The successful bidder will be responsible to afford the PCSIR Testing charges of Pesticides and provide its testing report on their own level / expenses and provide an undertaking regarding Malpractice and Freshness Certificate dully issued by the Manufacturing Company / Authorized Dealers of pesticides.
12. The supply order can be reduced or enhanced as per availability of funds. However, the supplier is bounded to be supplied the Additional Pesticides if required subsequently on the approved rates upto 30-06-2022.
13. The payment shall be made after receiving delivery of pesticides and on complete satisfaction of the undersigned.
14. The payment shall be made after deduction of the Income Tax, Professional Tax and Sales Tax on the total amount (standing by the Court).
15. In case of any irregularity / default committed by the supplier, the amount of C.D.R. shall be forfeited to the Government in full or part thereof.
16. The Purchase Committee reserves the right to reject any Quotation / Rate without assigning any reason.
