

PERCENTAGE RATE TENDER AND CONTRACT FOR WORKS GENERAL RULES AND DIRECTIONS FOR THE GUIDANCE OR CONTRACTORS

1. All works proposed for execution by contract shall be notified in a form of an invitation to tender posted on a board hung up in the office of and signed by the Municipal Engineer. This form shall state the work to be carried out, as well as dates for submitting and opening tenders, and the time, allowed, for carrying out the work, also the amount of earnest money to be deposited with the tender, an the amount of the security deposit to be deposited by the successful tenderer and the percentage, if any, any to be deducted from bills. Copies of the specifications, designs and drawing and Estimated rates _____ and any other documents required on connection with the work, signed for the purpose of Scheduled rates _____ identification by the Municipal Engineer, shall also be pose for inspection by the contract at the office of the Municipal Engineer during office hours.

2. In the event of the tender being submitted by a firm. it shall be signed separately by each member thereof, or, in the event of the absence of any partner, it shall be signed on his behalf by a person holding a power of attender authorizing him to do so.

3. Receipts for payments made on account of a work, when excused by a firm, shall also be signed by the several partners, except where the contractors are described in their tender as a firm, in which case the receipts shall be signed in the name of the firm by one of the partners, or by some other person having authority to give effectual receipts for the firm.

4. Any person who submits a tender shall fill up the usual printed form stating at how much per cent above or below the rates specified in the notice calling for tender he is willing to undertake the work. Estimated rates _____ Only one rate of percentage more or less on all the _____ shall be named tender, which purpose Scheduled rates _____ any alteration in the work specified in the said form of invitation of tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort, shall be liable to rejection; on single tender shall include more than one work, but contractors who wish to tender for two or more works, shall submit a separate tender for each; tenders shall have the name and number of the work to which they refer written include the same envelope.

5. The Municipal Engineer or his any authorized persons will open tenders in the presence of any intending contractors who may be present at the time and shall enter the amounts of the several tenders in a comparative statement in a suitable form. In the event of a tender being accepted, a receipt for the earnest-money forwarded therewith shall thereupon he give: to the contractor who shall thereupon for the purpose of identification sign copies of the specification and other documents mentioned in the notice calling for tenders. In the event of a tender being rejected, the earnest-money forwarded with such unaccepted tender shall thereupon be returned to the contractor making the same.

6. The Municipal Engineer shall have the right or rejecting all or each of new of the tenders.

7. The receipt of an accountant or clerk for any money pass by the contractor shall not be considered as any acknowledgment of payment to the Municipal Engineer and the contractor shall be responsible for seeing that the procures a receipt signed by the Municipal Engineer

8. The memorandum of work tendered for the memorandum of materials to be supplied by the Municipal Work Department and their issue rates, shall be filed in and completed in the office Municipal Engineer before the tender form is issued. If a form is issued to an intending tenderer without having been so filled in and completed, the tender shall request the office to have this done before the completes and delivers his tender. CONDITIONS OF CONTRACT

<p>Clause-1 The person/persons whose tender may be accepted (hereinafter called the (contractor shall, [A] (within ten days of the receipt by him of the notification of the acceptance of his tender) deposit with the Municipal Engineer in cash or Government securities endorsed to the Municipal Engineer (if deposited for more than 12 months) a sum sufficient (with the amount of the earnest-money deposited by him) with his tender to make up the full security deposit specified in tender [B] (permit the Municipal Committee at the time of making any payment tot him for work done under the contract to deduct such sum as will - with the earnest-money deposited by him - amount to ten per cent of all moneys so payable, such deductions to be held by the Municipal Committee by way of security deposit). All compensation or other sums of money payable be the contractor to the Municipal Committee under the terms of his contract may be deducted from, or paid by the sale of a sufficient part of the security deposit, or from the interest arising therefrom or from any sums which may be due or may become due to the contractor by the Municipal Committee on any account whatsoever and in event of his security deposit being educed y reason of any such deduction or sale as aforesaid, the contractor shall within ten days thereafter make good in cash or Government securities endorsed as aforesaid any sums which may have been deducted from or raised by sale of his security deposit or any part thereof.</p>	<p style="text-align: center;"><i>Security deposit</i></p>
<p>Clause-2 The time allowed for carrying out the work as entered in the tender shall be strictly observed by the contractor and shall be reckoned form the date on which the order to commence work is given to the contractor. The work shall throughout the stipulated period of the contract be proceeded with all due diligence (time being deemed to be the essence of the contract on the part of the contractor) and the contractor shall pay as the Municipal Committee (whose decision in writing shall be final) may decide on the amount of the estimated cost of the whole works shown by the tender for every day that the work remains un-commenced or unfinished afier the proper dates. And further, to ensure good progress during the execution of the work, the contractor shall be bound, in all cases in which the time allowed for any work exceeds one month, to complete one-fourth of the whole of the work before one-fourth of the whole time allowed under the contract has elapsed; one-half of the work, before one-half of such time has elapsed and three-fourths of the work, before three- fourths of such time has elapsed. In the event of the contractor failing to comply with the condition he shall be liable to pay as compensation an amount equal to one per cent, or such smaller amount as the Municipal Committee (whose decision in writing shall be final) may decide on the said estimated cōst of the whole work for every day that the due quantity of work remains incomplete; Provided always that the entire amount of compensation to be paid under the provisions of this clause shall not exceed ten per cent on the estimated cost of the work as shown in the tender.</p>	<p style="text-align: center;"><i>Compensation for delay</i></p>
<p>Clause-3 In any case in which under any clause or clauses of this contract the Contractor shall have rendered himself liable to pay compensation amounting to the whole of his security deposit (whether paid in one sum or deducted by installments) the Municipal Engineer, on behalf of the Municipal Committee, shall have power to adopt any of the following sources as he may deemed best suited to the interests of the Committee.</p>	<p style="text-align: center;"><i>Action where whole of security deposits is forfeited</i></p>
<p>To rescind the contract of which rescission notice in writing to the contractor under the hand of the Municipal Engineer shall be conclusive evidence, and in which case the security deposit of tie contractor shall stand forfeited, and be absolutely at the disposal of the Committee.</p>	
<p>To employ labour paid by the Municipal Work Department and to supply Materials to carry out the work or any part of the work, debiting the contractor with the cost of the labour and the price of the materials (as to the amount of which cost and price a certificate of the Municipal Engineer shall be final and conclusive against the contractor) and crediting him with the value of the work done in all respects in the same manner and at the same rates as if it has been carried out by the contractor under the terms of his contractor, the certified of the Municipal Engineer as to the value of the work done shall be final and conclusive against the contractor.</p>	
<p>To measure up the work of the contractor, and to take such part thereof as shall be un executed 'out of his hands, and to give it to another contractor to complete, in which case any expenses which may be incurred in excess of the sum, which would have been paid to the original contractor, if the whole work had been executed by him (as to the amount of which the excess certificate in writing of the Municipal Engineer shall be final and conclusive) shall be borne and paid by the original contract; and may be deducted from any money due to him by the Committee under Lie contract or otherwise, or from his security deposit or the proceeds of sale thereof or a sufficient part thereof.</p>	<p style="text-align: center;"><i>Contractor remains liable to pay compensation if action be not taken under clause 2.</i></p>
<p>In the event of any of the above causes being adopted by the Municipal Engineer, the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials, or entered into any engagements or made any advance, on account of, or with a view to the execution of the work or the performance of the contract; and in case the contract shall be rescinded under the provision aforesaid, the contractor shall not be entitled to recover or be paid any sum for any work therefore actually performed under this contract, unless and until the Municipal Engineer shall have certified in writing the performance of such work and the value payable in respect thereof and the contractor shall only be entitled to be paid the value so certified.</p>	
<p>Clause-4 In any case in which any of the powers conferred upon the Municipal Engineer by clause 3 thereof shall have become exercisable and the same shall not be exercised the non-exercise thereof shall not constitute waiver of any of the conditions hereof and such powers shall notwithstanding be exercisable in the event of any future case of default by the contractor for which by any clause or clauses hereof he is declared liable to pay compensation amounting to the whole of his security deposit, and the liability of the contractor for past and future compensation shall remain unaffected. In the event of the Municipal Engineer putting in force either of the power (b) vested in him under the proceeding clause he may, if he so desires, take possession of all or any tools, plant, materials and stores in or upon the works or the site thereof or belonging to the contractor, or procured by him and intended to be used for the execution of the work or any part thereof, paying or allowing for the same in account at the contractor rates, in case of these not being applicable at current market rates to be certified by the Municipal Engineer, whose certificate thereof shall be final, otherwise the Municipal Engineer may be notice in writing to the contractor or his clerk of the works, foreman or other authorized agent require him to remove such tools. plants materials, or stores from the premises within a time to be specified in such notice and in the event of the contractor failing to comply with any such requisition the Municipal Engineer may remove them at the contractor's expense or sell them by auction or private sale on account of the contractor and at his risk in all respects and the certificate of the Municipal Engineer as to the expense of any such removal, and the amount of the proceeds and expense of any such sale shall be final and co9nclusive against the contractor. <p>Clause-5 If the contractor shall desire an extension of the time for completion of the work on grounds of having been unavoidably hindered in its execution or on any other ~ ground, he shall apply in writing to the Municipal Engineer within 30 days from the date of the hindrance on account of which he desires such extension aforesaid, and the Municipal Engineer shall if in his opinion (which shall be final) reasonable grounds be shown, therefore authorize such extension of time, if any, as may, in his opinion, be necessary or proper.</p>	<p style="text-align: center;"><i>Extension of time</i></p>
<p>Clause-6 On completion of the work the contractor shall be furnished with a certificate by the Municipal Engineer of such completion but no such certificate shall be given nor shall the work be considered to be complete until the contractor shall have remove from the premises on which work has been executed all scaffolding, surplus materials and rubbish, and cleaned off the dirt from all wood-work doors, windows, walls floors, or other part of any building, in, upon or about which the work is to be executed, or of which he may have had possession for the purpose of the execution thereof, or until the work shall have been measured by the Municipal Engineer or his subordinate in-charge of the work whose measurements shall be binding and conclusive against the contractor. If the contractor shall fail to comply the requirements of this clause as to removal of scaffolding, surplus materials and rubbish, and cleaning off of dirt on or before the date fixed for the completion of the work; the Municipal Engineer may, at the expense of the contractor, remove such scaffolding, surplus materials and rubbish and dispose of the same as he thinksfit and« clean off such dirt as aforesaid; and the contractor shall forthwith pay the amount of all expense so incurred, and shall have no claim respect of any such scaffolding or surplus materials as aforesaid expect for any sum actually realized by the sale thereof.</p>	<p style="text-align: center;"><i>Final certificate.</i></p>
<p>Clause-7 No payments shall be made for works estimated to cost and than rupees one thousand, till after the whole of the work shall have completed and a certificate of completion plan. <p>Clause-8 A bill shall be submitted by the contractor each month on or before the date fixed by the Municipal Engineer for all work executed in the previous month, and the Municipal Engineer shall take on cause to be taken the requisite measurements fer the purpose of having the sum verified, and the claim, so far as admissible, adjusted if possible, before the expiry of ten days from the presentation of the bill. If the contractor does not submit the bill 'within the fixed as aforesaid, the Municipal Engineer may depute a subordinate to measure up the said work in the presence of the contractor, whose counter-signature to the measurement list will be sufficient warrant, and the Municipal Engineer may prepare a bill from such list which shall be binding on the contractor in all respects.</p>	<p style="text-align: center;"><i>Bills to be submitted monthly</i></p>

The time for the completion of the work shall be extended in the proportion and the additional'work bears to the original contract work, and the certificate of the Municipal Engineer shall be conclusive as to such proportion, and if the additional work includes any class of work, for which no rate is specified in the contract, then such class of work shall be carried out at the rates entered in the schedule of rates of the Municipality and if such last mentioned class of work is not entered in the schedule of rates of the Municipality then the' contract shall, within seven days of the date of his receipt of the order to carry out work, inform the Municipal Engineer of the rate which it is his intention to charge for such class of work, and if the Municipal Engineer does not agree to this rate he shall by notice in writing, be at liberty to cancel his order to carry out such class of work, and arrange to carry it out in such manner as he may consider advisable, provide always that if the contractor shall commence work or incur any expenditure in regard thereto before the rates shall have been determined as lastly herein before mentioned, then and in such'case he shall only be entitled to be paid in respect of the work carried out or expenditure incurred by him prior to the date of determination of the rate as aforesaid according to such rate or'rates as shall be fixed by the Municipal Engineer.
