

TENDER NOTICE

Sealed tenders (single stage, 2 Envelop) based on item/percentage rates are hereby invited on offers/ rates for supply of polythene bags and bhal/silt sweet for raising of potted plants under scheme titled "Ten Billion Tree Tsunami Programme" (Provincial Share) as detail below are required from the contractor/ firms enlisted/ renewed for the year 2021-22 with Engineering Council the following condition are applicable .

1. The tender will not be issued without authority letter on judicial paper from the contractor/ firm along with registered partnership deed, attested power of attorney on stamp paper.
2. The tender/ bidding documents are available and will be issued by the Accountant of the office of Divisional Forest Officer, Layyah during the office hours after publication of notice on PPRA website on payment of tender fee as mentioned below.
3. Tender rates and amount should be filled in figures as well as in word. Tender should be signed as per general direction given in the tender documents.
4. Conditional tenders will not be accepted.
5. Under the rule 35 of PPRA, the competent authority/ committee have the right to reject all the tenders prior to acceptance of a bid proposal.
6. Tender not accompanied with 05% Bid security of estimated Price in the shape of CDR from Schedule bank, will not entertained.
7. Last date of issuance of tender Form is up to **10.09.2021** from the office of DFO Layyah & tenders will be received on **11.09.2021** at **2.00 PM** and will be opened on the same day at **2.30 PM** in the presence of Tendering contractors or their representatives.
8. In case the total tendered amount is less than of the approved estimated (DNIT) amounting, the lowest bidder will have to deposit an additional performance security from the schedule bank equal to the tendered amount below estimated cost within 07 days after issuance of notice/ Acceptance of offers.
9. Tender/ bids received by post or through any other means shall not be accepted; the conditional tenders will be rejected.
10. In case of gazetted or local holiday against tabulated schedule, the date shall be considered as next working day, certainly with the same gap between dates of issuance and receipt of bids respectively.
11. The supplier firm must be registered with Sale Tax/Income Tax department and quote their GST/NTN numbers as well as professional Trade Tax Registration Certificate. All taxes and securities will be deducted as per prevailing rates and rules of provincial Government.
12. In case of High Up's meeting or non-completion of tender process, the next date of issuance of tender Form on **14.09.2021** from the office of DFO Layyah & tenders will be received on **16.09.2021** at **2.00 PM** and will be opened on the same day at **2.30 PM** in the presence of Tendering contractors or their representatives.
13. Any individual/ firm/ contractor declared as defaulter or involved in litigation would not be allowed to participate in tendering process.
14. Further conditions can be obtained from the office of Divisional Forest Officer Layyah in office hours.
15. The payment will be made to the firm/ contractor as per allocated/ release of funds by the Government.
