1. The Bid amount will be the net amount payable by the lessee to the Government in Ten (10) equal installments. All expenses on the provision, operation and maintenance of all facilities mentioned in the Bid documents will be borne by the Lessee and no deduction from the Bid amount will be admissible.
2. The Bidder shall sign each and every page of the Bid documents and initial all corrections therein and shall be bound in all respects to the conditions laid down therein. Highest Bidder shall deposit 1<sup>st</sup> installment in advance before taking over the possession of Toll Plaza.
3. Condition Bid will not be entertained.
4. Acceptance of the highest Bid shall rest with the Chief Engineer (M&R) Punjab Highway Department Lahore who reserves the right to reject the same without assigning any reasons thereof.
5. Documents pertaining to the Bid can be seen in the office of Executive Engineer Highway M&R Division-2 Faisalabad on any working day during office hours. The quoted bid of the Bidder will remain valid for 60 (Sixty) days and the highest Bidder will not claim refund of earnest money within 60 (Sixty) days and if the Department within 60 (Sixty) days does not accept the Bid then the Bidder will be at liberty to receive his earnest money back.
