TERMS & CONDITIONS FOR PURCHASE OF NON-INFECTIOUS WASTE CAREER FOR ALLIED HOSPITAL, FAISALABAD (2021-2022).

1. Tenders are invited from the **manufacturers / whole sale dealers**, registered with the Income Tax & Sales Tax Departments. Procurement will be made according to PPRA Rules 2014.
2. Bids will be submitted in sealed packet (single stage-two envelopes method) containing two sealed envelopes. One envelope will bear TECHNICAL PROPOSAL other FINANCIAL PROPOSAL. Initially only technical proposal will be opened by the Tender Opening Committee.
3. Any offer not received as per terms and conditions of the tender enquiry is liable to be rejected. No offer shall be considered if:
 - i. Tender form not purchased from Medical Superintendent (AHF).
 - ii. Received after the last date and time of receipt.
 - iii. The tender is unsigned.
 - iv. The tender is ambiguous/tempered
 - v. The offer is conditional.
 - vi. The offer is from a firm already black listed or suspended.
 - vii. The offer is received by Telegram/Fax/Email
 - viii. The offer not conforming the specifications as per tender inquiry.
 - ix. Received without Earnest Money.
4. Rates should be quoted on FOR basis Allied Hospital, Faisalabad.
5. Tenders will be submitted in double cover indicating the name of the addressee, tender number and date of opening.
6. Offers must be quoted on the prescribed tender form. Cash Receipt in original for the purchased tender must be attached with the offer.
7. Tender should be addressed to the Medical Superintendent, Allied Hospital, Faisalabad
8. The rates should be quoted both in words as well as in figures and including all Govt taxes (Sales tax & Income tax etc). Tenderers are required to furnish **Earnest Money @ 2%** on estimated price in shape of CDR which will be released on the completion of Guaranty.
9. The successful tenderer will be required to furnish **Security Deposit 05%** in shape of CDR in favour of Medical Superintendent, Allied Hospital Faisalabad.
10. The quotation should be submitted on the basis of accounting unit specified in the Tender Enquiry.
11. Supply should be completed within **6 weeks** from the date of supply order.
12. Firm will be responsible to supply the item according to the specification of the supply order.
13. 2% penalty of value of the supply order is to be charged for each month or part of month during which supply is delayed.

14. A certificate should be given by the Tenderers that they will be responsible **for free replacement of store** if the same is found sub-standard and or at variance with the specifications given in the tender enquiry.
15. Warranty period will be 03 years from the date of supply.
16. The store should be brand new.
17. Tenderer will provide price Certificate as per Specimen.
"It should be certified that the prices quoted in the tenders are not in excess of price, supplied to any other institution in the country and in case any discrepancy is noticed subsequently, tenderer will be responsible & undertake to pay the price difference."
18. The dispute if any will be settled through arbitration & decision of the arbitrator will be final.

For the purpose of determining the lowest evaluated bid, facts other than prices such as past performance, reputation of the product, financial soundness & other details as the procuring agency, at its discretion, may consider appropriate, shall be taken into consideration. The following merit point system for weighing evaluation factors / criteria can be applied for the "TECHNICAL PROPOSALS". The point score shall be mentioned in the "BID EVALUATION REPORT".

Note: i. if 100% manufacturer recommendations are not followed then zero point shall be awarded. ii. Manufacturer / Principal (bidder) shall clearly define which parts and accessories are replaceable and under warranty.
