Each envelope shall contain separately the **Technical Proposal and Financial Proposal** as per PPRA rules 2014(amended upto 2017).
6. The Procuring Agency reserves the right to reject all bids or proposals at any time prior to the acceptance of bid or proposal under PPRA rule 35.
7. **The Medical Superintendent THQ Hospital Pasrur** has the due right to disqualify a supplier or contractor if it finds at any stage that information submitted by him was false/in accurate /in complete under PPRA rule 19.
