WHEREAS you, M/S New Omni Traders, 31-Chinab Market, Madina Town, Faisalabad was supposed to deposit an amount of Rs.1,53,449/- (One lac fifty three thousand four hundred forty nine) in lieu of audit recoveries as per detail given below:-

AND WHEREAS you were asked to deposit the above said amount time & again vide this office letter No.HFH/Audit/P-25/2009-10/9015 dated 03.3.2011, HFH/Audit/P-25/2009-10/9692 dated 14.4.2011, HFH/Audit/668 dated 11.2.2015 & S.O.(P-1)4-21/2003(R/Pindi) dated 27.1.2016.

AND WHEREAS neither you have responded to our above said letters nor deposited the above said amount. This issue was discussed in Special Departmental Accounts Committee (SDAC) held on 12.12.2014 under Chairmanship of Additional Secretary (Admn). Health Department, Lahore wherein, it was recommended/directed that defaulter firms may be blacklisted.

AND WHEREAS you were given an opportunity of being heard in person under sub rule-2 of Rule-21 of PPRA Rules 2014 vide this office letter No.HFH/Audit/PDP-16/2009-10/3599-3602 dated 22.6.2016 to appear before the undersigned within seven working days from the issuance of letter but you did not avail this opportunity too.

NOW THEREFORE, in exercise of powers conferred upon me under Rule-21 of PPRA Rules 2014 do hereby **DEBAR & BLACKLIST** M/S New Omni Traders, 31-Chinab Market, Madina Town, Faisalabad with immediate effect for a period of three years and your firm is not eligible to participate in any public procurement process of RMC & Allied Hospitals, Rawalpindi.
