**Subject: BLACK LISTING OF MUKHALLAD FOUNDATION**

This is in reference to the agreement signed between Punjab Education Foundation and Mukhallad Foundation dated February 19, 2014. Mukhallad Foundation was selected as TPO to conduct 175 trainings in FY 2013-14 for the capacity building of low cost private school staff. As per contract agreement, an advance payment (40%) for subject trainings was made to Mukhallad Foundation on June 25, 2014 and final settlement was cleared on September 08, 2014. As per partnership agreement and attached guidelines, Mukhallad Foundation was required to pay honorarium to participants on last day of training and submit the claim to PEF for clearance.

A complaint from the principal of Rahnuma Public School Pakpattan, Mr. Rasheed Ahmed Tahir was received in the office of Chairman PEF on March 02, 2015 on which an inquiry committee was constituted. Inquiry Committee called all the stake holders including complainants and President Mukhallad Foundation, Mrs. Shaista Ahsan and gave them a fair chance to explain their point of view. After having analyzed the findings and relevant record, inquiry committee found Mukhallad Foundation involved in serious misconduct, misrepresentation of facts, misappropriation and fraud. Mukhallad Foundation has not only caused inconvenience for participants but also cheated PEF by producing fake receipts. In the process, Mukhallad Foundation has also damaged credibility and goodwill of PEF in the eyes of partner schools. Because of these facts, Inquiry Committee has recommended to Blacklist Mukhallad Foundation from all future assignments.

PEF Management has Blacklisted Mukhallad Foundation at PEF permanently according to clause 21 of PPRA rules 2014 (Amended till date) regarding blacklisting, due to its criminal, non-professional, fraudulent and deceiving acts. PEF Management is also forwarding the case to MD PPRA with the recommendations to blacklist Mukhallad Foundation for future assignments at all Government departments/Organizations in the best interest of the Nation and Country as a whole.
