NOTIFICATION

As per condition No.10 (II) "General Condition of the contract agreement" Rule.No. 19 of PPRA Rules 2009 and Rule No. 21 of PPRA rules 2014. Keeping in view poor performance of M/S. Linkers Asia brief circumstances of which are described below:-

The Institute of Blood Transfusion Service, Punjab, Lahore, had received 800,000/- HCV Rapid Device test (Ecotest Lot # 1411200) from M/S. Linkers Asia 64-H Johar Town Lahore on the direction of Lahore High Court Lahore vide Case. No. W.P.No. 25060/2014. The kits were supplied to the store of I.B.T.S. on 29-05-2014. After Technical Evaluation the supply was started to field blood units. As the Institute evaluates all the items being supplied to units on monthly basis, the said kits were found invalid during evaluation performed on 22-04-2016. The said company was immediately communicated vide letter no. 3127-31 dated 22-04-2016. On having no response from the said company, the reminders were posted at different times (Reminder-1 No. BTS/Store/5248-52, dated 04-July-2016. Reminder-2 No.BTS/Store/7027, dated 02-August-2016 and reminder-3 No.BTS/Store/7524, dated 23-August-2016). There was no response from M/S. Linkers Asia, against the reminders as mentioned. The company was called for personal hearing on dated 21-11-2016. The Chief Executive of the company Mr. Malik Akhtar appeared before the Director, I.B.T.S. Pb, Lahore and promised to rectify the matter within a week but again there has been no response by the company up till now.

M/S. Linkers Asia is hereby **BLACK LISTED** for all the purchases of IBTS for a period of 5 Years r.e.f. the issuance of this letter.

The recommendations are also being forwarded to PPRA for further perusal.
