Subject: BLACKLISTING OF MR. GHULAM ABBAS, SIALKOT CNIC NO. , UNDER RULE 21 OF PPRA RULES 2014 READ WITH CONDITION 21 OF BID DOCUMENT.

BRIEF FACTS:

A meeting of School Purchase Committee convened by the Principal on July 25, 2017 at 10:30 a.m. for auction/bidding of school canteen for the fiscal year 2017-18. 'Notice' was published in PPRA Dated 06.07.2017 & "Daily Jang" Lahore Dated 11.07.2017. Four bidders offered their bids before the School Purchase Committee. After having the contest between the these bidders; **Mr. Ghulam Abbas** offered highest bid of **Rs. 3,00,000/-** and the committee unanimously decided the auction/bidding of school canteen in his favor for the fiscal year 2017-18.

In this regard, the undersigned conveyed the concerned successful bidder to work / run the school canteen after signing an agreement subject to the fulfillment of terms & conditions of bid document. He advised to deposit bid amount @ Rs. 3,00,000/- as on or before 31.07.2017 vide this office work order No. QPSB/SKT/2017/171 dated 25.07.2017 & letter No. QPSB/SKT/2017/ 212 dated 03.08.2017.

It is a matter of concern that he failed to work / run the school canteen. Neither he signed an agreement nor deposited bid amount @ Rs. 3,00,000/- as per schedule.

He served a show cause notice vide No. QPSB/SKT/2017/219 dated 09.08.2017 and directed to submit his reply within seven days but he failed.

A personal hearing notice was served to him vide this office No. QPSB/SKT/2017/237 dated 17.08.2017 to defend his position. But he did not appear before the Purchase Committee on 21.08.2017 nor submitted any written defence. It shows that he has nothing to defend his position.

As per approval of Purchase Committee, the work order issued in favour of Mr. Ghulam Abbas S/O Maqsood Shah, Village Sandrana, Distt. Sialkot vide this office No. QPSB/SKT/2017/171 dated 25.07.2017 was cancelled vide this office letter No. QPSB/SKT/2017/ 245 dated 21.08.2017.

ORDER:

1. WHEREAS, despite repeated requests for run the school canteen after signing an agreement subject to the fulfillment of terms & conditions and depositing bid amount @ Rs. 3,00,000/- but you failed.
2. WHEREAS, the undersigned served a show cause notice vide No. QPSB/SKT/2017/219 dated 09.08.2017 and directed to submit his reply within seven days but he failed.
3. WHEREAS, a personal hearing notice was served to him vide this office No. QPSB/SKT/2017/237 dated 17.08.2017 to defend his position. But he did not appear before the Purchase Committee nor submitted any written defence. It shows that he has nothing to defend his position.

Forgoing of the above, as per decision of Purchase Committee, I, Mahmood Rabbani Anjum, Principal, Quaid-e-Azam Public School (Boys), Sialkot being Chairman, Purchase Committee empowered under sub rule 1 of Rule 21 of PPRA Rules 2014 read with condition 21 of bid document, hereby debar / blacklist **Mr. Ghulam Abbas S/O Maqsood Shah, CNIC No. 34603-2328752-1, R/O Village Sandrana, Tehsil & Distt. Sialkot** from participating in any public procurement process for 05 years & his bid security amounting to Rs. 5000/- be forfeited under condition 21 of bid document.
