No.: 9399 Lot No.: 2 (Laptops, Desktops & Printers) floated by Punjab Model Bazaars Management Company (hereinafter referred as PMBMC), the firm i.e. The Vital Enterprises is hereby Black Listed with immediate effect from PMBMC as the firm has deceived the PMBMC for submitting Fake Earnest Money CDR No.: 0608019 dated: 19th August, 2016 amounting, Rs. 97,000/- issued by the Dubai Islamic Bank Pakistan Ltd. The Bank confirmed on 13th June, 2017 that CDR is Fake.

The Procuring Agency (PA) advised the firm to appear before the Committee through the letter ref. No.: PPRA06/9/17 dated: 09-09-2017, 1st Reminder through letter ref. No.: PPRA07/9/17 dated: 14-09-2017 and final notice vide PPRA08/9/17 dated: 18-09-2017 but firm did not responded to any of the letters nor their any representative appeared before the Committee.

In due consideration of the facts of the case, PMBMC hereby blacklists M/s. **Vital Enterprises, M-34 Jeff Height Gulberg-III, Lahore bearing NTN: 1420678-1** on above mentioned charges of fraudulent/criminal practice. The said firm is hereby declared ineligible for practicing in any public procurement process in future.

It is, therefore, requested to please include the above mentioned firm in the list of blacklisted firms for the period of ten (10) years from the date of uploading on PPRA website and upload on the website of the PPRA as per sub rule 2(a) of Rule 21 of PPRA Rules in the Public Interest at large with intimation to this office please.
