Medical Superintendent Faisalabad Institute of Cardiology, Faisalabad invited tenders for the bulk purchase of Surgical Disposable Items (Main Medicine Store) for financial year 2016-17 on FOR basis. The said tender notice was published in Daily Jang (21-05-2016) (Annex I), Daily Express (20-05-2016) (Annex II), Daily Millat (29-05-2016) (Annex III) and also uploaded on the web site of PPRA (20-05-2016) (Annex IV) vide PPRA rule 12. The last date of receiving of tender was 07-06-2016. Technical offers of 28 nos of firms / contractors were opened on the same date by the tender opening committee of the Institute in presence of bidders / their representative (Annex V). The meeting of technical advisory committee was held on 13-06-2016 for the technical evaluation of bids received (Annex VI). During the evaluation M/s. Saru International technically qualified and financial bid was opened on dated 10.09.2016.

Following items are awarded to M/s. Saru International.

Supply order for Sr # 3, award # 92 for SURGICAL DRAPE/INCISE DRAPE WITH ANTIMICROBIAL 45X60 CM ADULT (Healthicon incise surgical Drape Jianxzi 3L Medical Industry China) Rs.645/- was issued to the said supplier vide order # 35108/FIC/FSD dated 04.10.2016 but the firm did not supply the stock within stipulated time i.e 15.02-2017.


1st reminder vide letter # 1310/FIC/FSD dated 10.01.2017 was issued to the firm to provide the stock at the earliest but the firm did not respond (Annex VII). 2nd reminder for failure to supply was issued vide letter # 4233/FIC/FSD dated 15.02.2017 and the firm was again directed to deliver the stock within 03 days because it is an emergency item, hospital is facing serious problems due to non availability of this item. Finally, letter for personal hearing was issued, vide letter # 10800/FIC/FSD dated 08.05.2017 (Annex IX). The representative of the firm appeared on dated 16.05.2017 and committed to supply the said stock on 19.05.2017 but did not give under taking in writing. The committee unanimously decided if M/s. Saru International failed to supply the said

stock within committed time period, its supply order will be cancelled and CDR will be forfeited along with the black listing of the firm for three years (Annex X). (533)

As the firm failed to supply the stock till date, therefore, according to PPRA rules 2014 # 21 Clause (3), ***If a procuring agency is satisfied that a contractor has acted in a manner detrimental to the public interest or good practices or has consistently failed to performed his obligation under the contract or his performance has not been up to mark or he is found indulging in corrupt or fraudulent practice, the procuring agency may, after affording him an opportunity of hearing and through a notification, debar him from participating in any public procurement process of the procuring agency for such period as the procuring agency may determine in the light of the circumstances of the case.***

in the light of above said rule the Institute is satisfied that the firm acted in a manner detrimental to the public interest and against the good practice. Further, the firm consistently failed to perform his obligations under the contract / his performance has not been up to the mark, therefore, ***the competent authority has decided to debar M/s. Saru International to take part in all the tenders of Faisalabad Institute of Cardiology, Faisalabad for three years.***


