ORDER

WHEREAS, being the lowest evaluated bidder an Advance Acceptance of Tender dated January 17, 2017/supply order at a total cost of Rs.8759000/-was issued to M/S Pyramid Technology Services, office No. 10-A 3rd floor, Hafeez Center, Lahore, vide this office No.1468/P&D dated 21-03-17 for the supply of 10 Entry Level Servers and 150 Computers to 10 High Schools in the District Toba Tek Singh upto 30-04-2017 as detail below:-

WHEREAS, the firm M/S Pyramid Technology Services, office No. 10-A 3rd floor, Hafeez Center Lahore did not deposit 10% performance guarantee amounting to Rs. 875900/- as per the condition No. 11 of the supply order.

WHEREAS, the firm M/S Pyramid Technology Services, office No. 10-A 3rd floor, Hafeez Center Lahore after 20 days of issuance of supply order informed this office vide their letter dated April 10, 2017 that they will only supply hardware portion without licensed windows but this office directed the firm vide this office No. 2451/P&D dated 5-5-2017 to supply the 10 Entry Level Servers and 150 Computers along with licensed windows as per the specification laid down in the tender documents. In response the firm made lame excuses in their letter dated 17-05-17 and tried to de-track this office.

WHEREAS, this office once again directed vide letter No. 3027 dated 26-05-2017 to the firm M/S Pyramid Technology Services, office No. 10-A 3rd floor, Hafeez Center Lahore to deposit performance guarantee and supply the requisite items within a week time. Instead of compliance, the

firm once again made lame excuses vide letter dated 1/6/2017. Therefore, the firm was provided an opportunity of personal hearing under Rule 21(2) of Punjab Procurement Rules 2014, on 19-06-2017 vide this office No. 3535/P&D dated 15-06-2017 to resolve the matter.

WHEREAS, in the personal hearing and written reply submitted by the firm's representative did not satisfy the then Chief Executive Officer, District Education Authority Toba Tek Singh.

WHEREAS, to meet the ends of justice the firm was given another opportunity of personal hearing under Rule 21(2) of Punjab Procurement Rules 2014, on 14-11-2017 vide this office No.5934 /P&D dated 10 -11-2017 to rectify the matter but firm's representative verbal and written reply did not satisfy the under signed.


NOW THEREFORE, I, Riaz Qadeer Bhatti, Chief Executive Officer, District Education Authority Toba Tek Singh being procuring agency and competent authority declare M/S Pyramid Technology Services, office No. 10-A 3rd floor, Hafeez Center Lahore as black listed and debar to participate in any procurement process for the period of three years and impose the penalty of forfeiture of bid security.
