No.DLR&D/Audit/2009-10/Vol-II/, Whereas, this office invited sealed bids for the purchase of Atomic Absorption Spectro Photometer duly advertized in daily Mashriq dated 01/12/2006, 06/12/2006 and 14/12/2006.

And whereas, the sealed bids were opened by the purchase committee on 27/12/2006 in the presence of the bidders, who volunteered to participate in the proceedings.

And whereas, the bid of M/S Aman Traders Rahat Abad University Town, Peshawar amounting to Rs.37,90,000/- for the purchase of Atomic Absorption Spectro Photometer found lowest and approved by the purchase committee.

And whereas, the successful bidder M/S Aman Traders supplied the machine to this Directorate and place the machine at Centre of Animal Nutrition Directorate of Livestock Research & Development Khyber Pakhtunkhwa, Peshawar in 2007, and did not deliver it to the Livestock Research & Development Station Paharpur D.I.Khan as per terms and conditions. The approved firm failed to install the machine and provide training uptill now, which is also against the terms and conditions already signed. In this regard, no certificate of the technical officer(s) of the centre, where the Atomic Absorption Spectro Photometer (AAS) was placed is available in the record and nor the certificate of the technical officer(s) of the same Centre was produced by the supplier.

And whereas, the Director Livestock Research & Development Khyber Pakhtunkhwa, Peshawar, as the chairman of the purchase committee for the said tender, and in light of the recommendations of the enquiry report, the undersigned, Director Livestock Research & Development Khyber Pakhtunkhwa, Peshawar being procuring entity in exercise of the power conferred under rule 44 (1) of Khyber Pakhtunkhwa procurement rule, 2014, **Blacklisting M/S Aman Traders Rahat Abad University Town, Peshawar for participation in bidding for supply of goods and services to any Government entity/agency for a period of three years.**
