**SUBJECT: BLACK LISTING OF M/S HATAF BLUE SECURITY SERVICES PVT. LTD.**

It is stated that M/s Hataf Blue Security & Services Pvt. Ltd. participated in the tender of outsource of Security Services at Faisalabad Institute of Cardiology, Faisalabad for the financial year 2019-20.

In this regard, a financial offer opening committee meeting held on 06.11.2019. CDR No.06350344 dated 24.09.2019 attached by M/s Hataf Blue Security Services Pvt. Ltd. was found suspicious (Annex-A). For clearance the CDR was sent to United Bank Limited, Kutchery Bazar Branch, Faisalabad.

United Bank Limited, Kutchery Bazar Branch, Faisalabad declared the above said CDR as 2.3 fake Instrument (Annex-B).

A show cause was issued vide letter No.31218/FIC/FSD dated 27.11.2019. M/s Hataf Blue Security Services Pvt. Ltd. did not submit any reply of the show cause notice.

After this personal hearing was called on 14.12.2019 vide letter No.33031/FIC/FSD dated 07.12.2019 in front of the committee constituted by the Medical Superintendent, FIC, Faisalabad. The personal hearing was attended by the representative of the M/s Hataf Blue Security Services Pvt. Ltd.

In Personal hearing the representative of M/s Hataf Blue Security Services Pvt. Ltd. admitted that the firm has submitted fake CDR.

Hence the committee unanimously recommends **debar/blacklisting** of M/s Hataf Blue Security Services Pvt. Ltd. for **ONE YEAR** for all tenders in this institute under **PPRA Rule 21 (1)(a)**.
