**OFFICE ORDER**

**Whereas** I, Prof. Muhammad Saleem, Medical director The Children's Hospital & The Institute of Child Health Lahore using authority in this case decided to proceed against **M/s. Uni Build Associates (Pvt) Ltd**, under PPRA Rules 2014 (amended) on the following charges under clause **21**: Blacklisting sub clause (a, b & c):

- a) Acted in a manner of determine to the public interest of good practice.
- b) Consistently failed to perform his obligation under the contract.
- c) Not perform the contract up the mark.

**And whereas, M/s. Uni Build Associates (Pvt) Ltd**, was asked to repair the sliding doors for operation theater no. 10 & 12 which were installed vide contract no. 1931/C dated 30.05.2012. Further AC Plant installed in inpatient block during the warranty period we faced problems are as follows:

- The 2<sup>nd</sup> Chiller's LCD is not Showing display.
- Cooling Tower overflow valve no. 08 is out of order.
- Cooling Tower fins are broken.
- Vacuum Pump no. 02 is out of order.

**And whereas**, a show cause notice was served to the firm (M/s. Uni Build Associates (Pvt) Ltd) vide letter No. 6438/CH&ICH dated 12.02.2020 for submission of reply till 18.02.2020 but the firm failed to submit its reply within stipulated time period.

**Now therefore**, the undersigned after detail scrutiny of record imposes following penalties.

1. Forfeiture of performance security / Guarantee.
2. Blacklist / debar the company / firm to participate in any procurement of The Children's Hospital & The Institute of Child Health Lahore for **02 (Two) years** with immediate effect.
3. A request to Managing Director, PPRA to nominate M/s. Uni Build Associates (Pvt) Ltd as blacklist firm and debar it from participating in any public procurement in Punjab for **02 (Two) years**.
