ORDER

1. This is with reference to the Show Cause Notice No. 01/P&C/MWMC/120/2020 dated 14-01-2020, served to M/S. Ayesha+Marriam Pvt Ltd, Faisalabad and the opportunity of personal hearing afforded to M/S. Ayesha + Marriam Pvt Ltd vide letter No. 06/CEO/MWMC/549/2020 dated 31-01-2020 and reminder letter no. 01-P&C/MWMC/155/2020. Date.16.04.2020. and final reminder no.02-P&C/MWMC/164/2020. Date. 20.05.2020.
2. The brief facts of the case are that M/S. Ayesha + Marriam Pvt Ltd, Faisalabad participated in the tender for the supply of Tyres under tender enquiry IPL No.3142 date.09.04.2019. The tender was floated in press as well as PPRA website, under Punjab Procurement Rules 2014 and opened on 24.04.2019, in presence of bidders. The procedure, Single stage two envelope was adopted. M/s. Ayesha+ Marriam Pvt Ltd, Faisalabad was lowest evaluated bidder and accepted the (LOA) on 28.07.2019 by requesting to change the Bid security in to Performance Security vide Bank Draft No.24813. dated.22.04.2019 amounting Rs. 532,906/-.
3. Subsequently, Draft Contract was sent to M/s.Ayesha + Marriam Pvt Ltd, Faisalabad for signatures but they did not sign the contract till date. They were repeatedly asked to comply their obligations under RFP clause 31.1 & 31.2 and PPR2014 but failed to comply the same till date and a formal show cause notice no. 01/P&C/MWMC/120/2020 dated.14.01.2020 was sent to explain their position but no response was received. A personal hearing notice No.06/CEO/MWMC/549/2020. Dated. 31.01.2020 was sent to appear before CEO, MWMC to explain their status, they appeared and submitted in written statement on 24.02.2020 and showed their willingness to sign the contract and delivery of stores, but neither they signed the contract and nor they delivered the supplies of tyres to date. Foregoing above proves misconduct of the firm, violation of clauses 31.1 & 31.2 of bidding documents, as well as PPR-2014 beyond any shadow of doubt. Therefore, M/S. Ayesha + Marriam Pvt Ltd, Faisalabad is hereby declared blacklisted from participation of public procurements in Punjab for three (03) years. The Main reasons of Blacklisting is non-compliance of instructions/clauses of bidding documents and non-delivery of stores and violation of PPR-2014(amended till date) Moreover, 100% performance security amounting to Rs. 532,906/- is confiscated, as well as letter of acceptance is rescinded.
