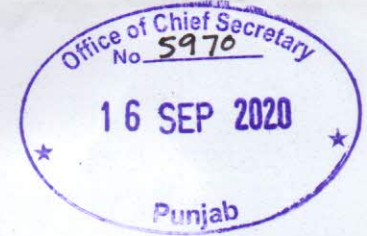

Owing to cancellation of various purchase orders which were placed on you during the last two years and later on cancelled with forfeiture of security money, showing a consistence bad performance on your part that has resulted into non availability of urgently required material to CFI creating a hindrance to the manufacturing of the coaches.

Non fulfilment of the contractual obligations has resulted loss to the department, therefore, your firm M/s.
