The is reference for violation of rate contract for FY 2019-2020 after winning award of contract by M/S Malik Saif and Company (SMC-Private) Limited, Ramwana post office, Khas Chak No. 290, RB Chak Zakhirao, P/O Kishan Garh, Tehsil Sangla hill, District Nankana sab, Sangla hill Punjab.

Reference to Auction Dated: - 21.04.2020 of Parking Stand Services (2019-2020), M/S Malik Saif and Company (SMC-Private) limited was directed to deposit monthly installments for the month of June 2020 Rs. 3,00,000/- (inclusive of PST + Income Tax). The firm was also required to deposit PST & Income Tax for the months of May & June 2020 but they failed to deposit the due installments along with the PST & Income Tax after reminder notices vide order # 5764/DHQ Dated: - 26.06.2020; vide order # 5973/DHQ Dated: - 04.07.2020. Again the firm was warned that the firm will be blacklisted if they did not respond to letter within 3 days after receiving of letter No. 6180/DHQ Dated: - 08.07.2020 has failed to submit monthly installments along with PST & Income Taxes of Parking Stand Services.

Hence as per PPRA Rules 2014 section 21 clause I, M/S Malik Saif and company (SMC-Private) limited is hereby debarred to participate in any procurement process for the period of three years from issuance of this intimation. The call deposit/bid security of Rs. 1,50,000/- is hereby fortified in favour of this office.

It is also requested to you to please debar the bidder from procurement of all procuring agencies.
