**OFFICE ORDER**

WHEREAS, during course of open Bid Process of Auction of Canteen Teaching Hospital, D.G.Khan for the year 2018-19 Mr. Muhammad Alam Qureshi S/O Farzand Ali was the highest bidder of said contract with the highest bid of Rs.7,000,000/-.

WHEREAS, Mr. Muhammad Alam Qureshi S/O Farzand Ali has submitted CDR No. 12513474 dated 29.08.2018 of Allied Bank Fawara Chock Multan of Rs.500,000/- on account of Bid Security as required under clause 10 of the terms and conditions of the contract of Canteen Teaching Hospital D.G.Khan for the year 2018-19 and the same was accordingly deposited into the Security Account of this Institution.

WHEREAS, Mr. Muhammad Alam Qureshi S/O Farzand Ali has neither deposited the remaining amount of contract despite issuance of following letters by the then Medical Superintendent Teaching Hospital, D.G.Khan.

1. Letter No. 87/29805/Teaching Hospital dated 04.09.2018 (copy enclosed).
2. Letter No./30400/Teaching Hospital, dated 08.09.2018 (copy enclosed).
3. Letter No. 87-31162/Teaching Hospital dated 13.09.2018 (copy enclosed).

WHEREAS, bid security of Rs. 500,000/- submitted by Mr. Muhammad Alam Qureshi S/O Farzand Ali in the shape of CRD has been forfeited by this Institution and the contract was awarded to second highest bidder M/S Fayyaz Ahmed S/O Muhammad Yaqoob for Rs.2,175,000/- vide Medical Superintendent Teaching Hospital, D.G.Khan letter No. 19824/(P.S) Teach: Hosp: dated 29.09.2018.

WHEREAS, during the course of Audit of this Institution for the period 2018-20 it was pointed out by Audit vide Para No. 26 that upon awarding contract to 2<sup>nd</sup> highest bidder M/S Fayyaz Ahmed S/O Muhammad Yaqoob for Rs. 2,175,000/- on 01.10.2018 resulted in huge loss of Rs. 4,825,000/- (Rs. 7,000,000 – Rs. 2,175,000) which should be recovered from Mr. Muhammad Alam Qureshi S/O Farzand Ali besides declaring him as black listed and forward the black listed case to PPRA authorities under intimation to Audit.

WHEREAS, Mr. Muhammad Alam Qureshi S/O Farzand Ali was served a Show Cause Notice vide this office No.8596-99/B&A/Teach: Hosp: Dated 03.10.2020 but Mr. Muhammad Alam Qureshi S/O Farzand Ali failed to submit any reply against this Show Cause Notice.

WHEREAS, Mr. Muhammad Alam Qureshi S/O Farzand Ali was served another Show Cause Notice vide this office No. 8690-93/B&A/Teach: Hosp: dated 07.10.2020 and Mr. Muhammad Alam Qureshi S/O Farzand Ali again failed to submit any reply against this Show Cause Notice.

WHEREAS, Mr. Muhammad Alam Qureshi S/O Farzand Ali was served 3<sup>rd</sup> and final Show Cause Notice vide this office No.8919-22/B&A/Teach: Hosp: dated 13.10.2020 and Mr. Muhammad Alam Qureshi S/O Farzand Ali again failed to submit any reply against this Show Cause Notice.

WHEREAS, to meet the ends of justice, on 03.11.2020 vide this office letter No.9423-26/B&A/Teach: Hosp: dated 31.10.2020: Mr. Muhammad Alam Qureshi S/O Farzand Ali was offered an opportunity of Personal Hearing but Mr. Muhammad Alam Qureshi S/O Farzand Ali failed to avail this opportunity, but he could not attend the proceeding on 03.11.2020.

Now, therefore after perusal of record and keeping in view the facts narrated above, I PROFESSOR DR. MUHAMMAD ASIF QURESHI, Principal D.G.Khan Medical College D.G.Khan and Allied Institutions, being Principal Procuring Officer / Head of Institution, in exercise of the power conferred upon me under the Rule, 21(a), (b) & (c) of the Punjab Procurement Regulatory Authority Rules, 2014 (amended upto date) hereby declare Mr. Muhammad Alam Qureshi S/O Farzand Ali, as "Blacklisted" and debar it for a period of one financial year to participate in any tender process of D.G.Khan Medical College and Allied Institutions with immediate effect.
