Subject: **BLACK LIST M/S REHMAN & COMPANY SECURITY, 11/A GULDASHT TOWN, ZARAR SHAHEED ROAD, LAHORE (MR. AZHAR ABBAS).**

Reference to the contract of security service KMSMC & Allied Institutions, Sialkot which was awarded to M/S Rehman Security System vide letter No. 990/KMSMC dated 22-06-2017 for a period of three years with annual renewal. The service provider was required to fulfill all the terms and condition which were stated in the agreement.

M/S Rehman Security System violated the terms and conditions of the agreement for which explanations were called vide letter No. 2752/KMSMC dated 24-05-2019, 2840/KMSMC dated 30-05-2019 and the payment of the company was also stopped according to the contract. When there was no positive response from the company a show cause notice vide letter No. 3456/KMSMC dated 28-06-2019 was served to the service provider for the non-compliance and for the recovery of extra amount paid. A reminder for the show cause notice vide letter No. 3532/KMSMC dated 02-07-2019 was also served.

The service provided lodged a complaint to MD PPRA for non-payment which is extremely objectionable as according to contract the payments of the salary of the security guards is not the responsibility of the client (Institution).

The service provider was requested vide letter No. 3605/KMSMC dated 05-07-2019 to vacate the institution and for winding up their setup on violation of the terms and conditions of the agreement. Instead of vacating the institution, the security company went into litigation and got stay from the Civil Court, Sialkot which is also against the agreement/ contract.

The Additional District Judge, Sialkot vide Civil Revision No. 198 of 2019 date of Decision 06-10-2020 disposed off the stay of M/S Rehman Security System.

Therefore, keeping in view of the above, the undersigned decided to proceed further for blacklisting of M/S Rehman & Company Security, 11/A Guldasth Town, Zarar Shaheed Road, Lahore (Mr. Azhar Abbas) under the PPRA Rules vide schedule 39 Sub Rule 6 of Rule 21 and clause 10 to clause 12 for violating the contract agreement.

It is therefore notified that the management of Govt. Khawaja M. Safdar Medical College & Allied Institutions, Sialkot blacklisted M/S Rehman & Company Security, 11/A Guldasth Town, Zarar Shaheed Road, Lahore (Mr. Azhar Abbas) in all over Pakistan to save the ex-chequer money and the valuable time of the authority.
