**Subject: DEBARRING OF M/S RADIANT MEDICAL PVT. LTD., AS PER SECTION 17-A OF THE PUNJAB PROCUREMENT REGULATORY AUTHORITY ACT, 2009 READ WITH RULE 21 AND SCHEDULE OF PUNJAB PROCUREMENT RULES, 2014 AGAINST THE SUBMISSION OF FAKE BANK GUARANTEES**

Dear Sir,

Please note that an inquiry was initiated under Section 17A of the Punjab Procurement Regulatory Authority Act, 2009 read with Rule 21 and Schedule to the Punjab Procurement Rules, 2014 against M/s Radiant Medical Pvt. Ltd., (the "Bidder") for submitting forged bank guarantees.

2. Subsequently, Show Cause Notice was issued to the Bidder in this regard and the Chief Operating Officer, IDAP was appointed as the Specified Officer of the IDAP for affording opportunity of personal hearing(s) to the Bidder, which was availed by the Bidder. The Specified Officer was empowered to investigate the matter, himself or through officer(s) of IDAP, summon the parties/issue notices/ correspond with any person for the purposes of investigation, as required, and make a reasoned fact-finding report regarding the blacklisting proceedings.


3. In furtherance of the Specified Officer's Report and after perusing the documents available on record, the IDAP Authority (Board) has held that the Bidder has violated Punjab Procurement Rules 2014 by:

- a. Indulging in corrupt practice (under Sub-Clause (d) of Clause (1) of Rule 21 of the Punjab Procurement Rules, 2014.

4. Therefore, M/s Radiant Medical Pvt. Ltd., has been debarred under Section 17-A of the PPRA Act 2009 read with Rule 21(1) and the Schedule to the Punjab Procurement Rules 2014 for a period of three (03) months and is declared ineligible for participating in any public procurement of IDAP (the Procuring Agency) from the date of issuance of the Order (copy attached herewith).
