

MINUTES OF THE MEETING FOR CONTRACT/AGREEMENT OF MINOR SCOPE OF CIVIL WORK UNDER REVAMPING THQ HOSPITAL MAILSI FOR THE YEAR 2017-2018 THQ HOSPITAL MAILSI HELD ON 03-04-2018.

The committee constituted regarding opening of tender and scrutiny/verification of Technical & financial bids for contract/agreement of Minor Scope of Civil Work under revamping of THQ Hospital Mailsi by the Medical Superintendent THQ Hospital Mailsi vide office orders No.291/THQ Mailsi dated 01-02-2018. The advertisement published in Daily Nawa e Waqt Pakistan News Paper on dated 15-03-2018 and on PPRA website on 17-03-2018

Two different firms offered their tender for Minor Scope of Civil Work of THQ Hospital Mailsi were received and opened under the chairmanship of Medical Superintendent Mailsi Secretary Health Council THQ Hospital Mailsi Chairman Committee and in the presence of participant's members of committee and in the presence of bidders/contractors on 03-04-2018 at 02.00 P.M in the office of Medical Superintendent THQ Hospital Mailsi. The committee checked the Technical Offers and Financial Offers in the presence of bidders on 03-04-2018 under the Chairmanship of Medical Superintendent THQ Hospital Mailsi Secretary Health Council THQ Hospital Mailsi.

The following bidders participated in tenders and offered their rates.

1. Pak Madina Corporation, Vehari Road Muhammad Nagar Burewala.
2. M/S Mohammad Tahir Mehmood Govt. Contractor Chistian.

Scrutiny committee examined all documents provided by the bidders, Technical bids and financial bids. After examining of Technical bids/documents & financial bids by the committee comparative statement of all tenders prepared and signed by the committee.

The below mentioned bidders are qualified for following tenders.

1. M/S Mohammad Tahir Mehmood Govt. Contractor Chistian.(provide financial bid within the limit of tender contract 4.99 million)


Below mentioned bidders/contractors were disqualified by the committee because they did not attach C&W enlistment certificate submitted the technical bid with tender.

1. Pak Madina Corporation, Vehari Road Muhammad Nagar Burewala.(technically disqualified by not providing of C&W certificate).

During Negotiation by the Chairman committee and members of committee M/S Mohammad Tahir Mehmood Govt. Contractor Chistian lowest bidder, agreed the execute required work at the rates approved by the Government/Chief Engineer Building as per TS Statement rates of estimate. The committee decided that the contract/agreement of Minor Scope of Civil Work under Revamping THQ Hospital Mailsi for the year 2017-18, be awarded to M/S

Mohammad Tahir Mehmood Govt. Contractor Chistian being lowest bidders.. The terms and conditions are mentioned on Contract/agreement. Committee also decided to issue work order upto the amount of Rs. 05 million only.


