

**MINUTES OF THE MEETING FOR CONTRACT/AGREEMENT OF MINOR CIVIL WORK
UNDER REVAMPING THQ HOSPITAL KABIRWALA HELD ON 26-06-2018 FOR THE
YEAR 2017-2018**

The committee constituted regarding opening of tender and scrutiny/verification of Technical & financial bids for contract/agreement of Minor Civil Work under revamping of THQ Hospital Kabirwala by the Medical Superintendent THQ Hospital Kabirwala vide office orders No.18-21/PROC/THQ dated 30-03-2018. The advertisement was published in News Paper on dated 10-06-2018 having IPL NO 6268 and on PPRA website on 12-06-2018.

06 bids for minor Civil Work at THQ Hospital Kabirwala from different firms were received till 12:00PM 26-06-2018. All bids were opened under the chairmanship of Assistant Commissioner Kabirwala (Chairman Health Council THQ Hospital Kabirwala and in the presence of members of committee and in the presence of bidders/contractors on 26-06-2018 at 12.30PM in the office of Medical Superintendent. The committee checked the Technical Offers and Financial Offers in the presence of bidders on 26-06-2018 at 12:30PM under the Chairmanship of Assistant Commissioner Kabirwala (Chairman Health Council THQ Kabirwala).

The following bidders participated in tenders and offered their rates.

The committee examined all documents provided by the bidders, Technical bids and financial bids. After evaluation of Technical bids/documents & financial bids by the committee, comparative statement of all tenders was prepared and signed by the committee.

The below mentioned bidders qualified for tenders.

Below mentioned bidders/contractors were disqualified by the committee because technically evaluating documents were missing

During further evaluation by the Chairman Committee and members of committee M/S Abdul Satar (Govt. Contractor) (lowest bidder), agreed to execute required work at the rates approved by the authority. The committee decided that the contract/agreement of Civil Work under Revamping THQ Hospital Kabirwala for the year 2017-18, be awarded to M/S Abdul Satar (Govt. Contractor) being lowest bidders. The terms and conditions are mentioned on Contract/agreement. Committee also decided to issue work order up to the amount of Rs. 4.48 million only.
