The bids for the procurement of Printing Material i.e. Flex, Banners & Posters for the of Punjab Commission on the Status of Women” were invited in accordance with the single stage 02 envelope procedure laid down in clause-38-2(a), Punjab Procurement Rules-2014. The tender notice was got uploaded at website of PPRA on 10 April, 2018. In response, following four (03) firms participated and offered their technical and financial proposals for the supply of Printing Material:-

1. M/s. Al-Falah Traders, Lahore.
2. M/s. A. Zephyr Printers, Lahore.
3. M/s. HWB Company, Lahore

In order to open sealed packages & evaluate the technical proposals offered by the above bidders for the purchase of Printing Material, a technical evaluation committee under the Chairmanship of Mr. Muhammad Usman Secretary (PCSW).

The meeting of Technical Evaluation Committee was held on 25.04.2018 at 11.30 AM to open, evaluate and finalize the sealed technical proposal received from above mentioned participating bidders. The Committee members announced the technical result as given below:

- i. Accepted the technical proposals of M/S, A. Zeypher Printer for supply of posters and M/S, Al-Falah Traders for supply of Flex, Banners & X-standees”.
- ii. Rejected the offer made by M/S, HWB Company being not fulfill the bid evaluation criteria on technical grounds.


In order to open sealed financial bids, received from successful bidders for supplying of Printing Material, the meeting of the Financial Evaluation Committee was held on 15-05-2018 at **10.00 AM** under the chairmanship of Dr. Shehla Javaid Akram Member PCSW Board in the Committee room of Punjab Commission on the Status of Women, Lahore.

In pursuance of Rule 38(2-a)-iii PPRA Rules-2014, the Financial Proposals submitted by technically qualified bidders M/s. A. Zephyr Printer and M/S, Al-Falah Traders was opened publically and unit price & bid amounts quoted by the bidder were announced. The Result Sheet / Financial comparative statement showing status of each item including comparison of the rate offered by the selected bidders as given below:-
