A meeting of the Committee was held on 09.11.2021 at 12.30 PM in the office of Deputy Director Wildlife, Lahore Region / Chairman for opening / evaluation of technical proposal for hiring the services of 08 No. Private Security Guards under the aforementioned development scheme. The Committee observed that four tender forms were sold out while the representatives of three firms participated in the bidding process. **M/s National Police Foundation Security Services, Lahore and M/s Real Protect Security Company (Pvt.) Ltd., Office No.90, 2nd Floor Bara Tower 36, Queen Road, Lahore** technically qualified. **M/s Rincon Security Systems (Pvt.) Ltd, Bedian Road, Lahore** could not qualify the technical criteria. Therefore, financial proposal of the said firm was returned un-opened (in original) due to non-responsive technical proposal vide letter No.2101/DDW/LHR/A/2021 dated 22.11.2021.


3. The representatives of the qualified firms was re-called for opening of Financial Bid on 23.11.2021 at 01.30 P.M vide letter No.2102/DDW/LHR/A/2021 dated 22.11.2021. The representatives of the qualified firms attended the meeting on the scheduled date, time and venue. The financial bids were opened and announced in the presence of representatives of the qualified firms. The result of financial bid as under:


