2. Memorandum and Articles of Association of the Firm / Registration Certificate of the Firm.
3. List of similar projects completed by the firm during last ten years with total cost of such projects and cost of consultancy services with date of start and date of completion.
4. List of similar projects in hand with total cost and cost of consultancy services of such projects with date of start and expected date of completion.
5. An original undertaking (on Judicial Stamp Paper duly attested by Oath Commissioner) by the consultants / Firm / JVs to the effect that "Neither the Firm / consultants / JVs nor its Directors / Stakeholders, as a whole or as a part of the Firm have even been black listed / defaulted by any Government Agency / Department / Organization and also that the information supplied by the Consultants / Firm / JVs is correct.
6. False/incorrect Information shall lead to disqualification.
7. Annual Audited Reports for the last 03-years.
8. Copy of NTN Registration and Punjab Revenue Authority (PRA) Certificate.
9. Personnel details / bio-data of qualified professionals in each field on the payroll of the Firm or associated with the Firm as per criteria.

The interested Firms fulfilling the above requirements should send their profile with above particulars / information as per Pre qualification Documents to the Office of undersigned by 12-02-2021 at 2:00 PM. The shortlisting of the firms will be done as per PPRA Rules amended upto date.
