### Request for Expression of Interest (EOI) for Third Party Validation (TPV) of Student Information System (SIS) data

Punjab Education Foundation (PEF) is an autonomous body established by Government of the Punjab for promotion of education through Public Private Partnership. PEF is looking for a Firm for Third Party Validation (TPV) of Student Information System (SIS) data of PEF. The estimated cost of the assignment in the light of approved budget is Rs. 11.63 million.

#### **Eligibility Criteria:**

Only the Firms meeting the following criteria will be eligible for short listing:

1. Firm should be registered with either of the following: (Legal Status of Firm)
  - Registration Certificate from SECP
  - Registrar of Firms
  - Recognized by Govt. of Pakistan
  - Relevant registration forum (In case of international firms)
2. Firm should be registered with Federal Board of Revenue (FBR) & Punjab Revenue Authority (PRA) and active on Tax Payer list.
3. Firm should be registered from Relevant Professional Body like PEC, ICAP etc. alongwith latest renewal letter / Relevant Professional Body like PSEB, PASHA.
4. Firm should have at least 5 years of overall experience (in case of JV/ Consortium, all non-lead partners should have minimum experience of 3 Years (supported by Evidence i.e Engagement letters/ contracts/ Work Orders etc.)
5. Firm has never been declared ineligible/blacklisted by Government / Semi-Government / Agency or Authority or any employer till date due to the any reasons. Same shall be provided on an affidavit (with a value of Rs. 100).
6. Firm already working for Verification of Financial/ Physical Data of PEF for last 10 years will not be considered.

**Note:** Verifiable supporting documents as proof for meeting the eligibility criteria and an affidavit worth Rs.100 shall be submitted certifying that Firm fulfills all laid down eligibility criteria for undertaking Third Party Validation (TPV) of Student Information System (SIS) data of PEF.

This request for EOI intends to invite reputed Firms in accordance with Rule 47 "Expression of Interest" of Punjab Procurement Rules 2014. Afterwards PEF will use Request for Proposal (RFP) for seeking proposals from the shortlisted Firms in light of Rule 48 of Punjab Procurement Rules 2014.

Interested Firms can obtain the EOI Document on payment of Rs. 1,000/- in cash. Sealed EOIs must be delivered at the address given below on or before **March 05, 2021** at 10:00 AM. The same will be opened at 10:30 AM on same day in presence of representatives of Firms who may wish to attend.
