2. Only registered Firms should respond.
3. In an event where the last date for submission of bids be declared a public holiday the due date for submission and opening of bids shall be the next working day at the same appointed timings and venue.
4. All taxes and duties must be included in the offered rates and will be charged as per Government policy.
5. 01-Year parts and service warranty for all the components on site for the quoted equipment should be offered as part of the bid along with maximum 48-hours of down time for all components including replacement of the whole unit (if required).
6. Bidders should clearly mention terms and conditions of Service Agreements for the supplied equipment after the expiry of initial warranty period of 01-Year.
7. Interested firms are required to deposit bid security @ 5% of the total estimated value of bid in the name of Section Officer (General / Admin), Office of Additional Chief Secretary (South Punjab), Bahawalpur, in form of Bank Draft / Pay Order / CDR, failing which the bid shall be considered as non-responsive and shall be rejected.
8. The tender must be delivered in person or through their authorized agents by intending bidders to the tender opening Committee in sealed envelope. No tender shall be accepted / received by post or through any other means.
9. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
10. The successful bidder shall be required to furnish performance guarantee @10% of the contract amount.
