TERMS & CONDITIONS:

- Tender documents can be obtained from the office of Deputy Director (P&D), WASA, immediately (i.e. date of uploading on PPRA website upto 03-04-2021 upto 11:00 A.M. on depositing requisite tender fee in WASA Account.
- Sealed tenders will be received and opened in Committee Room WASA Main Office Jail Road Faisalabad on 03-04-2021 Bids receiving time upto 11:00 A.M. & Opening time is 2:00 P.M.
- Only duly authorized representative of the contracting firms can purchase / receive tender documents on showing of valid renewal of PEC License, and enlistment in WASA, Faisalabad / HUD & PHE Department having relevant building Code & National Identity Card in original.
- Earnest money must be accompanied with the tender which should be valid for at least Ninety (90) Calendar days from the date specified for opening of the bids otherwise the same will not be entertained. Conditional tenders will not be entertained.
- All the work will be carried out strictly according to PHE, B & R specifications to the entire satisfaction of the engineer incharge.
- In case the total tendered amount from the bidder is less than 5% of the approved estimated (JNT) amount, the lowest bidder will have to deposit an additional performance security (in addition to performance security) from scheduled Bank equal to difference of tendered amount and estimated cost. The acceptance will be issued on production of additional performance security, which will be refunded as per contract agreement.
- All the procurement process will be done as per PPRA rule. Procedure of open competitive bidding (i.e. Single Stage Two Envelope System) shall be adopted.
- Procedure of open competitive bidding (i.e. Single Stage One Envelope System) shall be adopted.
- The bidders shall specify the name of manufacturer / registered supplier and specification he wants to offer along with the authorization by manufacturer / registered supplier.
- The bidder shall include all taxes and duties in the bid price.
- Supervisory staff will be engaged as per requirement on daily wage basis and Procurements shall be governed under the Punjab Procurement Rules 2014.
- If any further information is required regarding the tenders, please visit the office of the undersigned during working hours prior to date of opening.
- The tenderer shall at his own expense, inspect and examine the site and surrounding and obtain for himself on his own responsibility, all information that may be necessary for preparing the tender and entering into contract.
