Terms and conditions

1. Tender documents containing detail of work/specifications and terms& conditions can be purchased from the office of Director, Barani Agricultural Training Institute Dahgal Adiala Road Rawalpindi on cash payment of Rs.1000/- (non-refundable) office hours up to 07.04.2021. No tender shall be sold on the date of opening.
2. Tenders shall be received in the office of Director, Barani Agricultural Training Institute Dahgal Adiala Road Rawalpindi up to 08.04.2021(10.00a.m.)on the Original Bidding Document issued by the office along with Earnest Money @3% of bid amount through representative of firm/contractor
3. Tenders will be opened on same day 08.04.2021 at 11.00 a.m. in the presence of Tender Evaluation Committee of this office and representatives of tendering contractors who wish to be present at the time of opening. The site can be visited during office hours.
4. Tender will be submitted on letter head pad and on Original Bidding Document filling all the entries. All the pages of Bidding Document should be duly signed and stamped.
5. A CDR 3% of estimated cost for work as bid security in favor of Director, Barani Agricultural Training Institute Dahgal Rawalpindi, NTN registration certificate, certificate regarding Registration with Building Department as contractor and valid copy of CNIC must be attached with the tender / bidding document.
6. The Contractor will be bound to pay all taxes as per prevailing rules.
7. Decision of the Procurement/ tender Evaluation committee will be final. However, in case of any grievance, may be proceeded to Grievance Committee of this office.
8. The construction work will be completed on bill payment. No advance payment will be made.
9. Construction of boundary wall contrary to the standards / specifications of building department mentioned in the tender document will be rejected and performance security will be forfeited.
10. Complete construction work must be ensured within 40 days from the date of contract. In case of delay, Rs.1000/- per day fine will be charged.
11. The Contractor will be bound to submit complete bill in duplicate along with all necessary documents to this office immediately after completion of construction work and getting clearance certificate from inspection committee of this office.
12. The office of the Director BATI Dahgal Rawalpindi may reject all bids / proposals at any time prior to the acceptance of a bid or proposal as per clause 35, PPRA rules 2014 amended up to 06.01.2016.
13. Successful bidder / Contractor will be bound to submit 10% of total cost of contract amount in the form of Draft / pay order / CDR as Performance Guarantee in favor of Director Barani Agricultural Training Institute Dahgal Rawalpindi immediately after issuance of offer letter and before signing of contract. The amount of performance Guarantee will remain in the custody of this office for six months after completion of work.
14. Tenders / offers will be rejected if submitted incomplete, without required documents, submitted after due date & time, without CDR of bid security, unsigned, unstamped, ambiguous, conditional or if contractor is black listed.
15. In case, the date 08.04.2021 is declared a holiday, the tenders will be accepted and opened on next working day at the times mentioned above.
16. Construction work shall be governed by PPRA Rules amended up to 06.01.2016.
17. Single Stage- one envelop bidding procedure (Technical & Financial) as per rule 38(1) PPRA rules 2014 amended up to 06.01.2016 shall be adopted. (Tenders should be submitted comprising a single sealed package containing Technical & Financial bids)
18. The contractors already under process of disciplinary action, defaulter or black listed with Government / building department will not be allowed to participate.
19. The bidders are requested to give their lowest and final price as far as possible as there will be no negotiation on the price.
20. The contractor registered with FBR can only participate in the tender.
21. Receipt issued by this office as price of bidding document should be attached with the tender.
