2. Bidding will be conducted through single stage-two envelopes bidding procedure as per Rule-38(2)-(a) of PPRA rules 2014 (As Amended uptill now). The bid shall comprise a single packet containing two separate envelops. Each envelop shall contain separately the Financial and Technical proposal with following documents/ information noted against each.
 - a) **Technical Proposal:-** (Bidding documents, NTN Registration Certificate, GST Registration Certificate, Bank Statement, Details of Specifications of respective offering items copies of CDR/ Bank Guarantee/ Earnest money and 02 years' experience etc.)(Further detail is given in bidding Documents.).
 - b) **Financial Proposal** (Rate of respective items including all taxes/charges and original CDR/Bank Guarantee/Earnest money).

10. During technical evaluation, no amendments in the technical proposal shall be permitted.
11. The Financial Proposal of bids shall be opened publically at the time, date and venue announced and communicated to the bidders in advanced.
