2. The Performance Security at the rate of 10% of the contract price shall be deposited by successful bidder within three (03) days of the issuance of purchase order before executing the contract.
3. The participating bidders must be registered with sales Tax and income Tax department (copies of NTN & sales tax Certificates be attached).
4. The proposal must reach (by hand) in the office of Assistant Director (Procurement), PFA located at 83-C New Muslim Town Lahore till 11:00 A.M. which will be opened by the procurement committee on the same day according to aforementioned date & Time respectively in the office of **Director General Punjab Food Authority**, in the presence of bidders or their authorized representatives who wish to witness the tender process.
5. The procuring agency reserves the right to reject any bid/all bids or proposal without assigning any reason at any time prior to the acceptance of a bid or proposal under PPRA rule 35 (1).
6. **Procuring agency reserves the right to increase or decrease the required quantity on demand/budget basis/force majeure during the contract period.**
7. The bidders are requested to give final item wise rates inclusive of all taxes as no negotiations shall be made.
8. Incomplete and false information shall be liable for rejection of bids at any stage.
