

NOTICE INVITING TENDERS

Sealed tenders based on item rate are hereby invited, for the works mentioned below, from the contractors / firms enlisted / renewed with Communication and Works Department for the financial year in the field of Highway Works.

Tender documents can be obtained, from any of the below mentioned offices, on written request accompanied with attested copies of enlistment / upto date renewal letter, PEC License, Identity Card of contractor / managing partner / Director of the firm alongwith registered power attorney and on payment of printing and publishing charges in Shape of Challan Form 32-A deposited in any Main Branch of National Bank of Pakistan in respective District. The intending contractors should bring original Enlistment / paid G.R. However, CDR, Bank Draft / Cashier's Cheque from any scheduled Bank will also be acceptable in case of application received through registered courier.

Conditional tenders and tenders not accompanied with earnest money @ 5% of the estimated cost in shape of CDR / Bank Draft / Cashier's Cheque of any scheduled Bank will not be entertained.

Note: Tender will be issued to the contractors / Firm having Earnest Money @ 2% of estimated cost at the time of issuance of Tenders in shape of Call Deposit Receipt (CDR) / Bank Draft / Cashier's Cheque from any scheduled Bank in favour of the Executive Engineer, Highway Division (M&R)-II, Gujranwala.
