- Tender received after the due date & time will not be brought under consideration.
- Attested copies of income tax and sales tax number should be furnished by the firm along with the tenders.
- Competent authority may reject all bids / proposals at any time prior to the acceptance of a bid or proposal. Competent authority on request of bidder may communicate the grounds for rejection of any or all bids / proposals, but shall not be required to justify those grounds.
