Conditional tenders or tenders not accompanied with Earnest Money @ 2% of estimated price as per PPRA Rules-27 in shape of CDR of any scheduled bank in favour of Executive Engineer Highway Division, D.G.Khan and attested copies of Registered Partnership Deed and Power of Attorney in case of firms will not be entertained.
4. In case of authorized representative of firm, he should appear in person along-with original CNIC of attorney holder for submission of application.
5. The procuring agency may reject all bids or proposal at any time prior to acceptance of Bid or proposals under PPRA Rule-35 (Rejection of Bids).
