Last date/time for submission of documents for pre-qualification is 26<sup>th</sup> August, 2022/1500 Hrs. The EOI will be opened on same date at 1530 Hrs.

EOI application should be in English. Any misinformation, false and forged statement will lead to disqualification from being shortlisted/pre-qualified and any other action as per applicable laws. EOI Applications submitted or received after the closing time shall be rejected. The procurement process will be governed under the Punjab Procurement Rules, 2014 as amended from time to time.

The procurement of services would be for a term of three years subject to annual satisfactory performance review by Finance and Audit Committee and Board of Directors, at end of each year. It would also be subject to appointment by shareholders each year in Annual General Meeting as per Companies Act, 2017.
